## **Job Description Supplement**

## **Sedentary Work**

I. MACHINES, TOOLS, EQUIPMENT: Machines, Tools, Equipment, Electronic Devices, Vehicles, etc. used in this position.

Including but not limited to: Computer, printer, telephone, calculator, copy machine, other office equipment, facsimile machine. Automobile or light truck may be required to use for work purposes.

work purposes. II. PHYSICAL REQUIREMENTS: Describes physical conditions of this position. Select only one. A. Sedentary Work: Exerting up to 10 pounds of force occasionally and/or a negligible amount of force frequently to lift, carry, push, pull or move objects. Sedentary work involves sitting most of the time. Jobs are sedentary if walking and standing are required only occasionally and all other sedentary criteria are met. B. Light Work: Exerting up to 20 pounds of force occasionally and/or up to 10 pounds of force frequently. If the use of arm and/or leg controls require exertion of forces greater than that for sedentary work and the worker sits most of the time, the job is rated as Light Work. C. Medium Work: Exerting up to 50 pounds of force occasionally, and/or up to 20 pounds of force frequently and/or up to 10 pounds of force constantly to move objects. D. Heavy Work: Exerting up to 100 pounds of force occasionally, and/or u to 50 pounds of force frequently, and/or up to 20 pounds of force constantly to move objects. E. Very Heavy Work: Exerting in excess of 100 pounds of force occasionally, and/or in excess of 50 pounds of force frequently, and/or in excess of 20 pounds of force constantly to move objects.

III. PHYSICAL ACTIVITY: Physical activities with or without accommodations for disabilities for this position. Percent of a typical day involved in each applicable activity is noted. Specify the percent of a typical day involved in each applicable activity and note on the line next to that activity. Note: This will total more than 100% as several activities may be performed at one time.

## Percentage:

- 73% A. Sitting: Resting with the body supported by the buttocks or thighs.
- 10% B. Standing: Assuming an upright position on the feet particularly for sustained periods of time.
- 10% C. Walking: Moving about on foot to accomplish tasks, particularly for long distances.

- 1% D. Climbing: Ascending or descending ladders, stairs, scaffolding, ramps, poles, etc. using feet and legs and/or hands and arms.
- **10%** E. Balancing: Maintain body equilibrium to prevent falling when walking, standing or crouching on narrow, slippery or erratically moving surfaces.
- **2%** F. Bending: Lowering the body forward from the waist.
- **2%** G. Stooping: Bending body downward and forward by bending spine at the waist through the use of the lower extremities and back muscles.
- 1% H. Kneeling: Bending legs at knee to come to a rest on knee or knees.
- 1% I. Crouching: Bending the body downward and forward by bending leg and spine.
- **0%** J. Crawling: Moving about on hands and knees or hands and feet.
- 5% K. Twisting: Moving body from the waist using a turning motion.
- **5%** L. Reaching: Extending hand(s) and arm(s) in any direction.
- 5% M. Pushing: Using upper extremities to press against something with steady force in order to thrust forward, downward or outward exerting up to 10 pounds of force.
- **10%** N. Pulling: Using upper extremities to drag, haul or tug objects in a sustained motion exerting up to 10 pounds of force.
- 2% O. Lifting: Raising objects from a lower to a higher position or moving objects horizontally from position-to-position through the use of the upper extremities and back muscles exerting up to 10 pounds of force.
- **80%** P. Finger Dexterity: Picking, pinching, typing or otherwise working primarily with fingers rather than with the whole hand or arm.
- **60%** Q. Grasping: Applying pressure to an object with the fingers and palm.
- 60% R. Feeling: Perceiving attributes of objects, such as size, shape, temperature or texture by touching with skin, particularly that of fingertips.
- **60%** S. Repetitive Motions: Substantial and continuous movements of the wrists, hands, and/or fingers.
- **80%** T. Talking: Expressing or exchanging ideas by means of the spoken word. Those activities in which detailed or important spoken instructions must be conveyed accurately, loudly or quickly.
- **100%** U. Hearing Acuity: The ability of perceive speech and other environmental sounds at normal loudness levels.

100%	V.	Visual Acuity: The power to see at a level which allows reading of numbers and text, operations of equipment inspection of machines, etc.

	A.	Outdoors: The worker is subject to outside environmental conditions. There is not effective protection from weather conditions such as wind, moisture, sunlight, extreme temperature changes, etc.

	C.	Indoors and Outdoors: The worker is subject to both environmental conditions. Activities occur inside and outside.

	E.	Heat: The worker is subject to extreme heat. Temperatures are above 100 degrees for periods of more than one hour.
	F.	Noise: The worker is subject to noise. There is sufficient noise to cause the worker to shout in order to be heard above the ambient noise level.
	G.	Vibration: the worker is subject to vibration. There is exposure to oscillating movements of the extremities or whole body.
	H.	Hazards: The worker is subject to hazards. This includes a variety of physical conditions, such as proximity to moving mechanical parts, electrical current, working on scaffolding and high places and exposure to high heat or chemicals.
	I.	Atmospheric Conditions: The worker is subject to atmospheric conditions. One or more of the following conditions affect the respiratory systems or the skin: fumes, odors, mists, gases or poor ventilation.
	J. flu	Oils: The worker is subject to oils. There is air and/or skin exposure to oils and other cutting ids.
